Identifies that a system of drainage should be incorporated in all basements waterproofing schemes and that water pressure may come to bear on a Basement Structure at some stage in its useful life. Clearly, this design implication identifies that all systems must be designed and installed with water ingress in mind although it may not be present at feasibility/design stage.
